### Context of the Roundtable

#### Aarhus Convention & Nuclear (ACN) process:

The Aarhus Convention establishes a number of rights of the public with regard to the environment. It provides for a right of access to information on public decisions impacting the environment, a right to participate in environmental decision-making and a right of access to justice should the afore-mentioned rights be denied.

The ACN (Aarhus Convention and Nuclear) participatory process was initiated in early 2008 by the European Commission Directorate General for Energy (DG ENER) together with Nuclear Transparency Watch. The aim of the ACN process is to investigate the implementation in practice of the Aarhus Convention in the context of nuclear activities. The ACN Roundtables involve various partners (national authorities, technical support organisations, operators of nuclear activities, civil society organisations, together with concerned international organisations). In the field of Radioactive Waste Management, an ACN European Roundtable has been previously held in April 2010.

### Objectives of the 2021 ACN Roundtable on RWM:

The European context of public participation in the field of RWM has changed significantly in the last decade. Council Directive 2011/70 /Euratom of 19 July 2011 on RWM¹ has introduced requirements into EU law for information and public participation in the decision-making process, which reflect the provisions of the Aarhus Convention. The Directive had to be transposed by EU Member States by 23 august 2013. After a first report on the implementation of the Radioactive Waste Directive published in 2017², stating the progress made, as well as the need for additional efforts to be made in a number of areas, a second EC report on the implementation of the directive, based on MS second national reports, was adopted in December 2019³. A study has also been carried out at the request of the European Commission (DG ENER) on the practical implementation of these transparency provisions by a consortium of civil society organisations (BEPPER study) whose proposals have yet to be put in discussion between the different categories of concerned actors.

In addition, civil society access to expertise and R&D was identified as a major issue in the conclusions of the first phase of the ACN process (2008-2013). Important progress has been made in the context of Euratom R&D with several European research projects (SITEX II, JOPRAD and EURAD) that have enabled the development of innovative models of interaction between civil society with the main RWM stakeholders R&D activities.

The objective of this roundtable is therefore to make a waypoint on the implementation of the Aarhus Convention in the area of RWM at European level, and in particular along the implementation of the Radioactive Waste Directive transparency provisions as well as on the important issue of public access to research and expertise. The Roundtable will also be an opportunity for reviewing important aspects of transparency in the national context of RWM management such as Germany, France, Sweden, UK & Czech Republic.
