WHO ARE WE?



NBG (in German: <u>Nationales Begleitgremium</u>) is an independent, pluralistically composed social committee. NBG tasks are determined by statute. Members are elected into the NBG (either by the government or citizens) and participate

voluntarily.

- Transparency during each step of the search procedure
- A selection procedure based on solid scientific and ethical principles
- Self-reflective participation to enable learning

WHAT DO WE DO?



Tasks of the NBG

As an independent body and in the interest of the common good, we chaperon the search for a high-level radioactive waste disposal site.

- Communication and exchange with all stakeholders
- Identification of tensions and possible conflicts at an early stage
- Contribute to the mediation of conflicts
- Make voices heard and ensure that criticism and suggestions from the public find their way into the search process
- Make recommendations to political actors
- Inspection of data generated, analysed and reported by formal institutions involved in the search process (we do this ourselves and via experts)
- Discussion and debate over key topics, such as public participation, developments with temporary storage sites for high-level radioactive waste, and content of main reports' findings and gaps

WHAT WE DON'T DO?



NBG Boundaries

- NBG is not a judge; rather, it is a facilitator, an observer, and a forewarner of potential problems
- NBG is limited in its ability to inspect data, reports, and analyses. It does not aim to outperform other actors, but instead to identify potential gaps and mistakes
- Concerns and challenges to official documents (e.g. the Interim Report on Sub-Regions) are primarily to be examined by their author, the `Bundesgesellschaft für Endlagerung (BGE)' (Federal Company for Radioactive Waste Disposal). The NBG acts when protected data needs to be reviewed as its members have this right under the law.
- The NBG is not responsible for the organization of the Sub-Areas Conference or for public participation. These are responsibilities of the `Bundesamt für die Sicherheit der nuklearen Entsorgung (BASE)' (Federal Office for the Safety of Nuclear Waste Management). The NBG can, however, inform the BASE of concerns.

The SUB-AREAS CONFERENCE (CANDIDATE AREAS FOR A REPOSITOR Nationales FÜR EIN FAIRES VERFAHREN

- Under the law, a Sub-Areas Conference is to be organized by concerned citizens, impacted regions, etc.
- Dates of the Sub-Areas Conference are: February 5-7, 2021, April 15-18, 2021, June 10-13, 2021.
- The aim of the Sub-Areas Conference is to evaluate the Interim-Report on Sub-Areas produced by the BGE and to make recommendations

WHAT WE PLAN TO DO AT THE SUB-AREAS CONFERENCE?



- NBG will observe the process in order to support it, learn from it, and evaluate it
- NBG will serve as a go-to actor during the Sub-Areas Conference when there are concerns about the actions (or non-actions) of other official stakeholders or the process
- NBG plans to conduct a peer review of the process
- As deemed appropriate, the NBG will review the geological data collected and models used by the BGE which are the basis of the Interim-Report.
